4. Details of our assessment

This report is issued in response to an incident reported to NRW

This report replaces CAR_NRW0044747 removing the previously stated MAX Suspended solids failure. Suspended solids limit in the permit is a LUT and therefore this sample does not breach condition.

Permit version in effect - 31/05/2023

On 2 July 2024 Natural Resources Wales (NRW) were informed via incident report (WIRS ref: 2410100) of an issue with the Final Effluent (FE) at Trebanos Waste Water Treatment Works.

An assessment was undertaken by the Environment Management Duty Officer and a Site Controller (EMSC) was dispatched to site to assess impact to the river and collect compliance/evidence samples as necessary.

EMSC collected samples of the FE along with corresponding upstream and downstream samples from the River Tawe.

The following table shows the results of the sample analysis undertaken by NRW's Analytical Services.

The final effluent was show to be discharging above the permitted MAX limits for BOD. Ammoniacal nitrogen and Suspended solids were also shown to been in excess of LUT limits, however this is not scored as this was not a pre-planned routine sample as per 4.2.2 of TGN 7.01 - How to Comply with your environmental permit

Parameters described in Table 3.1a are as follows:

BOD - 40mg/l LUT - 80mg/l MAX

Ammoniacal nitrogen - 25mg/l LUT - 50mg/l MAX

Suspended Solids - 45mg/l LUT

NON-COMPLIANCE - CCS 2 (BOD) - Condition 3.1.1 - The Limits given in schedule 3 table S3.1 shall not be exceeded.

As per the 10-day storyboard sent to NRW on the 1 August 2024, the reason for the non-compliance is given as following "A gearbox failure on one of our surface aerators inhibited solids recycling and resulted in a decrease in our final effluent quality".

ACTION - Provide maintenance records of the gearbox to the 6 months prior to 2 July 2024, including any scheduled or unscheduled. Please ensure these records detail what work was undertaken on this gearbox including reasons why and any recommendations made by service engineers. Due **29/10/24**.

Note:

Two further site visits were undertaken on the 3 July and 4 July. On both occasions further compliance samples were taken. Results show the effluent had returned to compliance by the 3 July.
