4. Details of our assessment

A desk top study of the permitted site Pets At Rest, EPR/BP3798FS, has been undertaken to understand the history of the site and provide some ongoing advice.

The permit was issued on 09 October 1992 to operate a Pet Cemetery for the disposal of dead domestic pet carcasses or their cremated remains, taking place at the site at a rate of less than 10 tonnes of waste per day. The total capacity of the site shall be less than 25,000 tonnes.

According to our records the site has never operated. A review of aerial photographs showed no change to the permitted area.

You have held this permit for almost 33 years and have not utilised it. Regulations have changed since this permit was issued, and therefore further information has been included in the covering letter to this Compliance Assessment Report regarding surrendering your permit.
