### 4. Details of our assessment

**06/03/25**

A site visit was carried out on Thursday 6th of March 2025. In attendance were Environment Officer Callum Murray and Senior Environment Officer Natalie Wrangham. The weather was dry and mild throughout the visit, with very little rain in the week prior. The outfall location in Forest Wood Quarry's Discharge permit EPR/CB3696CN was the first place that was checked for signs of discolouration. The watercourse immediately downstream here was very slightly discoloured, although a different colour to the images reported down at Talygarn Lake. The actual outfall from the quarry was identified as being

at NGR ST 02249 79527, within a raised manhole on the road verge. The quarry discharge was clear. The entrance to Talygarn Lake was checked next, with the water here still discoloured as seen in the initial WIRS report. The water here was very slow moving. Following the watercourse upstream from this location is not feasible due to lack of access and dense vegetation. Upstream of the lake, the Dyfrgi is fed by many small tributaries and drainage ditches crossing farmland. From the closed Sevenoaks fishing lakes, the Dyfrgi was followed downstream as far as access allowed, but there were no signs of any discolouration or potential sources of silt pollution.

Officers CM and NW then spoke to Ryan Jones and Ian Bowen in the Forest Wood Quarry office to discuss any irregularities with the permitted discharge quality or volume that could have impacted the downstream water quality. Meter readings and photos from the settlement lagoon all indicated normal and acceptable discharge throughout the pollution event seen at Talygarn Lake, so this was ruled out as a source.

Historically there have been issues with surface water leaving the quarry and entering the Nant Rhydhlog from the area just below the site office / wheel wash area. Whilst on site CM and NW spoke with Ryan Jones and Ian Bowen about methods currently used to control and prevent surface water leaving site. We were informed that road sweepers are currently used during wet weather to remove silty water from this location. We discussed some potential improvements that could be considered to help prevent dirty surface water leaving site during heavy rainfall events, including but not limited to; removing the build up of silt from inside the surface water drains; installing silt socks over the drain covers to capture solids from any water that does enter the drain, and installing a temporary, removable bund to prevent water running offsite at the location of a missing kerbstone.

Natural Resources Wales acknowledges the complications surrounding the ownership of the surface water drainage assets at this location. It is appreciated that the land on which the drainage sits is not owned by Aggregates Express Quarry Products Ltd, nor are they responsible for the maintenance of these assets.
