### 4. Details of our assessment

OSM permit exceedance notification received by NRW on the 23<sup>rd</sup> December 2024 for a breach of Ammonia & BOD limits from an OSM sample taken on the 16<sup>th</sup> December 2024. On the 7<sup>th</sup> March 2025 an OSM exceptional circumstances report was sent to NRW which

provided details in photos of evidence which showed Fat, Oil & Grease residue in the WwTWs.

The situation was not self reported as a WIRS, a requirement under the current 16\_02 guidance and we believe that it may have lead to a significance impact at the time form the evidence provided. Due to this delay any investigation by NRW was not possible. Permit conditions 4.3.1 and 4.3.2 require notifications to be made as soon as reasonably practical following detection but within 7 days unless otherwise agreed (Schedule 5). Conditions below:

### **4.3 Notifications**

4.3.1 Natural Resources Wales shall be notified as soon as reasonably practicable following detection, within the site of the regulated facility of:

- (a) any malfunction, breakdown or failure of equipment or techniques, accident, or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution; and
- (b) any breach of a limit specified in schedule 3 table S3.1 (including individual exceedances of limits which are covered by condition 3.1.2).

Any other significant adverse environmental effects, which may have been caused by the activity, shall also be notified to Natural Resources Wales as soon as reasonably practicable following detection.

4.3.2 The information provided under condition 4.3.1 shall be supported by sending the information listed in schedule 5 to this permit within the time period specified in that schedule.
