Further to your letter dated 28th of April 2025, ECL have been appointed by Abril Industrial Waxes Limited (“Abril”) to assist with providing the additional information as detailed in your letter. The further information required is provided in *blue, underlined italics*.

“An overview of the new production line, including a flow diagram of the new process. Reason: The non-technical summary and main report gave reference to the additional raw material and the emission point associated with the additional production line but did not provide an overview of the new production line. We require a brief summary of the new production line.”

An updated Non-Technical Summary (NTS) (AIWL.01.01/NTS – Issue 2) and an updated Environmental Permitting Technical Requirements (EPTR) report (AIWL.01.01/EPTR – Issue 2) has been included with the supporting documentation submitted alongside this response to provide this information.

Please refer to Sections 2.1 and Appendix I of Issue 2 of the NTS and Section 1.1 and Appendix I of Issue 2 of the EPTR.


“Include any possible odour emissions (channelled or fugitive) and any action/mitigation in the environmental risk assessment.”

An updated Environmental Risk Assessment (ERA) (AIWL.01.01/ERA – Issue 2) has been included with the supporting documentation submitted alongside this response to provide this information.

Please refer to Section 3.1 and Table 6 of Section 4.1 of Issue 2 of the ERA.

“Confirm what standards the bunds (used for containment) are built to (for example CIRIA 736).”

Abril have confirmed that, subject to approval of the environmental permit variation application, new bunds will be built in accordance with the CIRIA 736 standard. Abril will make use of an external consultant to advise on this and can provide NRW with the bund documentation once the works have been undertaken.




Section 5.11. of Issue 2 of the EPTR and Section 5.2 of Issue 2 of the ERA, submitted alongside this response, have also been updated to confirm Abril's intentions to build bunds to the CIRIA 736 standard.
