4. Details of our assessment

Andy Prestt, Carriers and Brokers Officer went for a site inspection of the permitted site BB3497FN on Thursday 8th May 2025. The reason for the visit was because the waste carriers license of the site - CBDU017771 expired on 21.08.2023 and has not been renewed since.

Upon attempting to visit the site the gate was locked and secured, with no sign of vehicles or evidence of activities. The site was in good condition, but non-operational.
