## Warning letter

Further to enquires made by Natural Resources Wales in relation to waste received from The Treatment Hub Ltd at Tir John Landfill, Swansea, between 1<sup>st</sup> January 2019 to 31<sup>st</sup> December 2019 the following offence has been identified:

## Offence

It is an offence for a person, namely Enovert South Limited to fail to comply with, or contravene a condition of an environmental permit

### **Contrary to Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016**

Enquiries found that Enovert South Limited had failed to comply with the following permit conditions of permit number EPR/TP3935LA at Tir John Landfill, Wern Terrace, Off Fabian Way, Swansea, SA7 9XT:

2.7.1 Wastes shall only be accepted for disposal if

- (g) all the relevant waste acceptance procedures have been completed, and
- (h) they fulfil the relevant waste acceptance criteria.

2.7.7 - The operator shall maintain and implement a system which ensures that a record is made of the quantity, characteristics, date of delivery and, where practicable, origin of any waste that is received for disposal or recovery and of the identity of the producer, or in the case of municipal waste and multiple collection vehicles, of the collector of such waste. Any information regarded by the operator as commercially confidential shall be clearly identified in the record.

**Date:** Between 1 January 2019 and 31 December 2019

On this occasion we are issuing you a **warning letter** as a response to the above offences. However, our decision could change if any further relevant information comes to light, including, but not restricted to, information that:

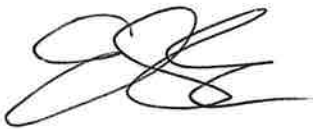
- you have committed earlier offences
- the environmental impacts of these offences are greater than we presently understand them
- the offences are continuing or have been repeated
- you have committed other offences of which we are presently unaware.

We will take these offences into account if we consider that you are involved in any future offending.

This warning does not:

- prevent any other prosecuting authority taking action against you/the Company; or
- affect our right to issue enforcement, clear-up or remediation notices, or seek recovery of costs or damages according to law.
