## Warning letter

**Environmental Permit:** EPR-WP3231NB

**Regulated Facility:** The Creamery, Aberarad, Newcastle Emlyn, SA38 9DQ

Further to Natural Resources Wales' (NRW) compliance assessment of environmental permit EPR-WP3231NB, in particular quarterly monitoring returns, during 2023 and 2024 at the above address, operated by Dairy Partners (Cymru Wales) Ltd (the company), NRW have identified the following offence:

*Offence: Contravention of Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 - failure to comply with or contravene an environmental permit condition.*

*Date: Between March 2023 and April 2024*

The above offence is relating to breach of permit condition 3.5.1 in that the company failed to undertake the monitoring specified in Schedule 3, Table S3.2 required by condition 3.5.1 of the permit. Specifically, failing to monitor various point source emission parameters to water in 2023 and 2024. For further details on this matter please consult compliance assessment report CAR\_NRW0043546. Permit condition non-compliances related to this matter are also acknowledged in CAR Form<sup>1</sup>.

NRW acknowledges that since the offence date the company has taken steps to remedy the non-compliance.

On this occasion we are issuing you with a **warning letter** as a response to the above offence. However, our decision could change if any further relevant information comes to light, including, but not restricted to, information that:

- The company has committed earlier offences
- the environmental impacts of these offences are greater than we presently understand them
- the offences are continuing or have been repeated
- the company has committed other offences of which we are presently unaware.

We will take this offence into account if we consider that you are involved in any future offending.

This warning does not:

- prevent any other prosecuting authority taking action against the company; or
- affect our right to issue enforcement, clear-up or remediation notices, or seek recovery of costs or damages according to law.
