Section 4.2 A(1) (a) (i)	Reforming natural gas via steam reformer.	From receipt of natural gas, through steam reformation and purification and passed to storage. Boiler to provide the steam.

Hydrogen storage	Storage from receipt of Hydrogen from purification or road tanker, through to export by pipeline at North Western pipe track.	
Cooling water	Cooling water discharge to and from cooling tower by pipeline at North Western pipe track.
