What is the project title?

Brockweir Bridge Resurfacing Works

Briefly describe what you want to do

The carriageway surfacing of Brockweir Bridge is in very poor condition, with significant areas of potholes, patching, and loose grit accumulation along the edges of the carriageway throughout the entire length of the bridge and its approaches. We plan to undertake resurfacing work and repair any minor surface-level concrete defects only in the carriageway area (verges not included), cleanse the deck drainage system from carriageway level, and replace the existing bridge expansion joints. Works will be carried out in a controlled environment, with a total closure of the bridge implemented during works and debris netting installed on the parapets to encapsulate the works area.

When do you want the licence to start?

Band 1 licences are typically issued for one year, subject to consultation.

Construction materials will be transported to the bridge via tipper trucks or large goods vehicles by accessing the total closure. Minimal storage of materials on site will be required, as surfacing material will be laid as it arrives on site. Similarly, waterproofing and bridge expansion joint materials are stored in holding tanks on the trucks and are installed directly from these vehicles.
