An inspection was undertaken on Thursday 5th September 2019. The purpose of the inspection was to assess compliance with an action detailed in a Regulation 36 Notice that has been served on the company.

During a previous inspection (05/02/2019) a non-compliance was recorded with the permit as non-hazardous waste was being stored outside of the building in an area that did not benefit from an impermeable surface with sealed drainage system. This is in contravention of the Environmental Permit.

Subsequently, a Regulation 36 Notice was issued (30/04/2019) that required the following:

All non-hazardous waste must be moved so that it is stored in a building or container on an impermeable surface with a sealed drainage system.

The deadline for compliance with this action was 1st August 2019.

I can confirm that on Thursday 5th September 2019 Gwendraeth Valley Recycling Limited was compliant with this specific aspect of the Notice. As a result, storage of non-hazardous waste appeared to be compliant with the Environmental Permit also. This waste has been removed from site.

Please note, as per the Notice, you must produce a Fire Prevention and Mitigation Plan for the site by Friday 29th November 2019. Failure to comply with this action may result in enforcement action being taken against you.
