On 31st October 2018, DID fail to comply with a Regulation 36 Enforcement Notice served on 22nd March 2018, requiring compliance with conditions of an Environmental Permit No. LLN/SM/003 (EAWML 34065)(EPR-LP3098FJ), contrary to Regulation 38(3) of the Environmental Permitting (England and Wales) Regulations 2016.
