4. Details of our assessment

This report details the proposed metal recycling trial at the Stericycle Bridgend Clinical Waste Treatment Plant and Transfer Station, permit reference number EPR/PP3430UL.

TRIAL PROPOSAL

The site intend to install a magnet separator on the exit conveyor of the treatment plant to allow the extraction of ferrous metals from the treated waste flock. The trial is to determine the percentage of metal waste within the treated flock and how much would be removed for recovery. Metal waste(s) removed, via the magnet separator, will be stored temporarily on site where it will then be transported off site to another waste facility pending further treatment. The trial will last for 7 days.

ENVIRONMENTAL RISKS

The site have informed Natural Resources Wales (NRW) that the proposed trial activity does not impose any additional environmental risks such as odour, noise, dust, loss of containment or potential pest control issues. No additional emission points have been identified.

PERMIT VARIATION

Following the completion of the trial, if the site intend to permanently install / adopt this operating technique into their respective process then a permit variation would be required as well as updating local documentation such Standard Operating Procedures (SOP) and the sites Environmental Management System (EMS).

DECISION

NRW Officers Greg GARDNER and Mostyn WALL have reviewed the trial proposal document and are satisfied that the due to the minimal environmental risk, duration of the trial and the minimum impact on permit compliance that the 7 day trial can be undertaken.
