4. Details of our assessment

This was a pre-arranged site inspection to primarily meet the Health and Safety Manager that has been newly appointed and to check progress on the management system.

A general site walk round was conducted with the Health and Safety Manager and Environmental Officer. The effluent treatment supervisor also joined us when the effluent treatment plant (ETP) was inspected. The balancing tank level was high with a small percentage stored in the divert tank. Suspended solids, pH, temperature and flow which were showing on the HMI were within the permitted emission limits values (ELV) for the discharge point W1. The autosampler and sample storage was viewed, all was in order. There was a moderate localised odour in the ETP area. The dewatering equipment for the sludge was not in operation at the time of the visit and a skip of the filter cake was being stored in the bunded area. The sludge is continuing to be removed off site for land spreading.

Different flow rates to the ETP process are currently being trialled to provide a more consistent effluent stream.

Microbiology checks of the plant are conducted quarterly by a contractor and results are discussed with the ETP supervisor. The contractor also provides regular support and advice on the running of the plant.

Regular meetings with ETP staff and Engineering are being held about the maintenance schedules for the ETP.

Discussions were held on the progress of reviewing the management system, the maintenance schedules and critical spares. These will be audited during the next site inspection.

All actions except for (6) from the previous visit, CAR_NRW0046457 have all been completed.
