This Compliance Assessment Report (CAR) has been raised in relation to the Q1 2025 monitoring and waste returns.

Q1 Monitoring Returns - Air

The Q1 monitoring returns were received on 26th April 2025 for emissions from A1, A12 and A13 emission points in compliance with the timescales stipulated in permit condition 4.2.3. Reported parameters for A1, A12 and A13 were in compliance with the Emission Limit Values (ELV's) defined in Schedule 3 table S3.1.

Q1 Monitoring Returns – Water

No water was discharged during this reporting period.

Q1 Waste Returns

The Q1 waste returns were received on 26th April 2025 for wastes accepted for the quarter January to March 2025 within the timescale stipulated in permit condition 4.2.5. The waste returns were reviewed and there were no issues identified.
