4. Details of our assessment

This was an unannounced routine site inspection, carried out by Waste Regulation Officer Joe Weatherley. The last inspection at the site was on 12/04/2019. The last waste return for quarter 1 of 2025 was a null return. Prior to visiting the site the officer examined the waste return records for the site and they were found to be accurate and up to date.

At the time of the inspection the weather was warm sunny and dry. The officer was met at the locked gates to the site by the Environmental Manager who facilitated access. The Environmental Manager explained to the officer that the site does not operate on a regular basis and activity is determined by demand for materials from industry. The existing road onto site is raised due to the quarrying activity that has taken place either side of it. There are large mineral and rock deposits beneath the road that will be exposed for removal in the near future. In order to achieve this, a new access road is being laid onto site.

Several piles of inert waste and quarried material were present on site from the last active period. A plant vehicle was present to one side of the site and is being used in the ongoing road installation.

Please update Natural Resources Wales when activity resumes at the site.
