4. Details of our assessment

This was an unannounced, routine site inspection by Waste Regulation Officer Joe Weatherley, accompanied by Waste Regulation Officer Amy Henderson. The weather was cold and overcast, the ground wet from rainfall. Upon arrival at site, the officers were greeted by a site operative who accompanied them to the office to sign the attendance register. The site permit was present in the office but was not easily found by the operative. Please ensure the permit is accessible to all staff members and anybody who is obliged to work within the conditions of the permit. The site diary was present in the office, with past and current entries, appropriate and legible.

The officers commenced the inspection, accompanied by the operative. The waste types on site were segregated, clearly labelled and conversant with the list of allowed wastes in the site permit.

Approximately fifteen fridge freezers were standing out in the open adjacent to the storage unit designated as their container. The operative informed the officer that they are left like that due to the container being full at the time the items are brought to the site. Furthermore, that they may stand in the open for several days until placing in the container or removal from site.

Action: As fridge/freezers contain toxic gases, they are a hazardous waste stream. As such they should be stored within clearly identified, secure lockable containers, as per table 2.1 of the site permit, under *Limits of activities*. Please provide adequate storage for the amount of fridge freezers brought to the site

The storage of WEEE has been scored as a C3 breach of Schedule 2, table 2.1 of the site environmental permit: *limits of activities*.

Generally the site is clean, tidy and well managed.
