4. Details of our assessment

Natural Resources Wales (NRW) officers Paul Challender and Carter Shone attended the Chirk Landfill/Pen y Bont FCC permitted site to conduct a routine site inspection of the physical aspects of the landfill. The NRW officers were escorted by the Compliance Advisor at all times during the inspection.

Chirk Landfill is a closed landfill that has moved into definite closure and is in the aftercare stage. As such, no waste is accepted and the permitted activities are limited to landfill gas and leachate control operations. Periodic monitoring is conducted and periodic reporting is submitted to NRW for appraisal. Both monitoring and reporting are in compliance with the timeframes detailed in the permit.

During the inspection no issues of note were detected with the gas, leachate or surface water management systems.
