### 4. Details of our assessment

The pumping station was visited as part of NRW's pre-season bathing water work in association with a visit to the nearby Llanerch CSO.

It was only the pumphouse building and several manhole covers that were seen at the pumping station. It's understood that the pumping station spills to sea via the old Nefyn tidal tanks - which weren't seen.

Nefyn beach was designated as a bathing water under the Bathing Water Regulations by Welsh Government in 2024.

It's noted from the EDM returns for 2024 that the site spilt 160 times for 2197 hours. This raises the following questions:

1. Is the EDM data correct?
2. How many of these 160 spills were between the 1<sup>st</sup> of May and end of September 2024?
3. 2197 hours is roughly equal to 91 days, or 25% of the year. Why is this so high?
4. Was this site spilling anytime around the 23<sup>rd</sup> of July 2024, or anytime around the 6<sup>th</sup> of September 2024? - when elevated bacterial results were noted at the bathing water.
5. Is this site on Dwr Cymru's radar as being next to a newly designated bathing water in terms of spills?
6. Is any investment or remedial work to reduce spills planned for this discharge?
