4. Details of our assessment

The site was visited as part a visual inspection of Trearddur Bay designated bathing water to protect bathing water quality.

The location of the pumping station was seen and an outfall pipe seen on the adjoining beach. It was unclear whether this was an outfall for the pumping station, or merely a surface water drain, but no evidence of sewage derived pollution was found.
