3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

4. Details of our assessment

On the 4th April 2025, a visit was carried out to the abstraction that takes place from the River Dee under licence WA/067/0005/0030. The reason for this visit was to follow up on non-compliances from the visit carried out on the 3rd March 2025, as covered in the compliance assessment report - CAR_NRW0046604.

It was found that works had taken place to cover the gaps on either side of the structure that hold the screens in place with mesh. The mesh is within the 4mm screening requirement for this time of year.

A continuous assessment must be made of the positioning of the mesh to ensure it hasn't moved over time following differing flow patterns. Should this occur, a more permanent solution must be installed.

It was found that 4 of the 6 screens were sat on the concrete, with a seal being created by a metal strip set in the concrete that runs along the back of these.

The other 2 screens were sitting higher, therefore not on the concrete. It was found that these were sat on gravel, with a large amount sitting on the screen itself. This build up of gravel was creating a blockage, but there were gaps in places below the screens.

An email was received from the Canal and River Trust on the 7th April 2025, with pictures showing the work that had been carried out to install the mesh.

Due to the gaps under the screens, the current screening is not compliant with the

conditions of the licence as an abstraction is taking place while the screening isn't sufficiently preventing the entrapment, entrainment or impingement of lamprey at the point of abstraction. This must be corrected by carrying out the required action by the 25th April 2025.
