4. Details of our assessment

This Compliance Inspection Report (CAR) follows an unannounced site inspection at Hafod Landfill, in response to odour incidents.

Immediately before carrying out the site inspection, NRW officers completed offsite odour monitoring at the following locations: New Hall Road, Shellbrook Drive, Vauxhall Industrial Estate, Ruabon Road, Stryd Las, Bangor Road, Heol Kenyon, Y Gesail, Nant Park Estate. Slight landfill gas odours were detected near the farm on New Hall Road but not at any other location.

The Regional Manager accompanied NRW officers during the inspection.

Preparatory works were continuing in advance of drilling and installing 7 new vertical gas wells in Cell 5b and the installation of 14 new pin wells on the northern flank of Cell4. The drill rig had arrived on site and works were due to commence later that week.

Slight, transient landfill gas odours detected near the SE corner of the site.

The odour suppression unit was operational near the site boundary of New Hall Road.
