### 4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine, unannounced site inspection at Hafod Landfill.

Immediately before carrying out the inspection, NRW officers completed offsite odour monitoring at the following locations: New Hall Road, Shellbrook Drive, Vauxhall Industrial Estate, Ruabon Road, Heol Kenyon, Y Gesail, Nant Park Estate, Bangor Road. Slight landfill gas odours were detected at the site entrance when driving onto site but not at any of the other locations.

The Regional Manager accompanied officers during the inspection.

Works were progressing on site to address the recommendations raised following the landfill gas audit by NRW's Landfill Emissions Reduction Project (LERP) Team in November 2024 (see CAR\_NRW0045947):

- 7 new vertical gas wells installed and connected in Cell 5b.
- 2x horizontal gas wells installed in Cell 5b and another due to be installed imminently.
- Pin wells were being drilled into the northern flank of cell 4.
- Preparation works completed on cell 4 and on top of cell 5a in advance of the installation of temporary capping with LLDPE plastic.

Landfill gas odours were detected near the active tipping face, these were localised and transient. Pin wells were being installed during the inspection.
