4. Details of our assessment

On the 29th April 2025 an announced site inspection was undertaken by NRW officers Phil Harper, Rebecca Harwood and Rick Prichard, Industry & Waste Regulation team.

The primary purpose of the visit was to take water samples of perimeter groundwater and gas monitoring wells as part of ongoing work to determine whether the landfill site can be moved into a state of definite closure.

The operator already undertakes an extensive suite of groundwater monitoring on a monthly basis. Groundwater monitoring wells were selected as part of the sampling programme to determine whether third party analysis agreed with NRW analytical data, validating the data range.

All water samples were taken using sampling bailers apart from at groundwater monitoring well 1.0 which was sampled using a watera® tube. A full list of sample data and sampling observations is attached to this compliance assessment report, areas of note will be discussed in turn below.

Elevated Chloride Levels on the Upgradient Side of the Site.

The sample data shows elevated chloride levels in upgradient gas monitoring wells. This requires further investigation to ensure that water samples are representative.

Action 1: Purge at least 3 well volumes from perimeter gas wells and repeat the water sampling and analysis exercise. The additional analysis should be submitted with the Q2 monitoring data for April to June 2025.

Ammonia and Chloride Level Exceedances at Monitoring Wells GW2 and GW3.

Ammonia and chloride level exceedances were observed at groundwater monitoring wells GW2 and GW3, attracting permit breaches under permit condition 3.1.5. These permit breaches will be consolidated with quarterly monitoring data for Q2 of 2025 and scored during the quarterly data review. No score has been applied within this compliance assessment report.

Action 2: Continue to monitor groundwater boreholes and investigate any trends.

No other permit breaches were observed during the site inspection.
