3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

You are non-compliant with your licence.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

A site visit was carried out on the 19th March 2025 to the abstraction in place on the Afon Clochnant under licence WA/067/0003/020/V001.

During the visit, there was no abstraction taking place due to the flow conditions. When checking the abstraction returns on the portal from 2019 onwards, there appears to be no returns submitted and are all 'outstanding' since 2019.

Condition 8.1 (i) (Records) states that 'The Licence Holder shall record readings of the electrical output and the corresponding quantity of water abstracted at the same time each week, as determined using the calculation checklist attached to this licence or at such other intervals as may be approved by NRW in writing. (ii) The Licence Holder shall send to NRW a copy of the records required by Condition 8.1 (i) above within 28 days after 31 March in each year, and also within 28 days of being so requested in writing by NRW. (iii) The Licence Holder shall keep all records for at least 6 years, and shall allow NRW to inspect them during all reasonable hours.'

To remain compliant with the licence, you will need to submit abstraction returns via the online portal for the years 2019-2024 and must do so within the given time frame stated above. These returns will then be assessed against the maximum quantities and another CAR form will be produced which outlines whether abstraction quantities are compliant with the conditions of the licence. An inspection of the outfall found that there was no screen in place on the discharge outlet. Condition 9.7 (i) states that no abstraction shall take place unless the Licence Holder has installed a screen with spacing no greater than 30 millimetres to the discharge outlet pipe to prevent the entrapment, entrainment or impingement of fish. An action is required to install a 30mm screen on the outfall pipe to remain compliant with the licence.
