4. Details of our assessment

This Compliance Inspection Report (CAR) follows an unannounced site inspection at Hafod Landfill, that was completed after receiving a large number of odour incidents.

Immediately before carrying out the site inspection, NRW officers completed offsite odour monitoring at the following locations: New Hall Road, Shellbrook Drive, Vauxhall Industrial Estate, Heol Kenyon, Y Gesail, Heol Orsaf, Bangor Road, Nant Park Estate. No landfill gas odours were observed at this time.

The Regional Manager was on site and accompanied NRW officers during the inspection.

The height of several leachate chambers was being raised. Landfill gas/ leachate odours were detected in the vicinity of LC3/LC4 while these works were being completed.

Some transient landfill gas odours observed on top of Cell 5a.

Preparatory works were being carried out in advance of drilling 7 new vertical gas wells in Cell 5b and installing 14 new pin wells on the northern flank of Cell 4.

The operator was setting up an odour suppression unit that will be operational along the site boundary of Bangor Road/ New Hall Road.

Following the inspection, NRW officers completed offsite odour monitoring at the following locations: Bangor Road, Heol Orsaf, Heol Kenyon, Rhosllanerchrugog, Nant Park Estate and New Hall Road. Slight, transient, landfill gas odours were detected at Heol Orsaf and by the site entrance. Landfill gas odours were not detected at any other location
