4. Details of our assessment

A site visit was carried out on the 19th March 2025 to the impoundment in place on the Afon Clochnant under licence WA/067/0003/021/V001.

During the visit, it was observed that an extra metal weir plate is in place in addition to the drawings which creates a fourth pool for ease of fish movement. Although there are currently no concerns with the flow through the hands off flow notch, it was observed that gravel is accumulating on the right hand side of the structure behind this. This needs to be

monitored to ensure any gravel build up does not prevent the correct flow from taking place.
