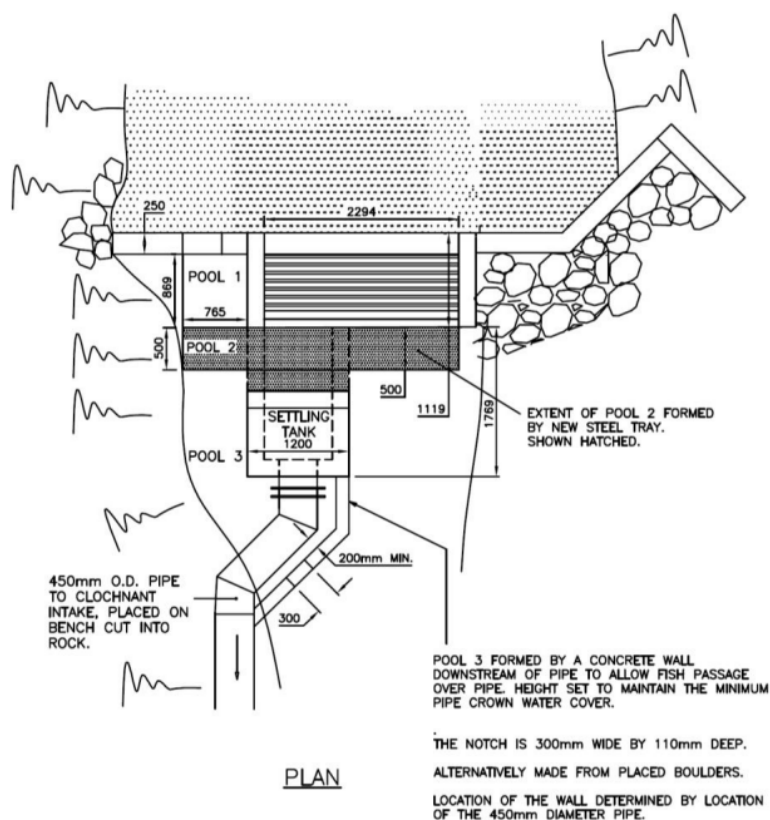
This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

A site visit was carried out on the 19th March 2025 to assess the impoundment on the Nant Cwm Tywyll under licence WA/067/0003/023/V001. This found that a concrete wall shown in the drawings of the licence is not in place. The drop from pool 2 goes onto a concrete pad rather than dropping into pool 3. It was discussed on site in place of the concrete wall that a boulder wall will be created to raise the depth of pool 3. This should be above the level of the concrete pad to ensure no fish are stranded on the pad.

Please consider any seasonal restrictions on when works can take place. Closed season for in river works and bird nesting season etc.





Although there are currently no concerns with the flow through the hands off flow notch, it was observed that gravel is accumulating on the left hand side of the structure behind this. This needs to be monitored to ensure any gravel build up does not prevent the correct flow from taking place.
