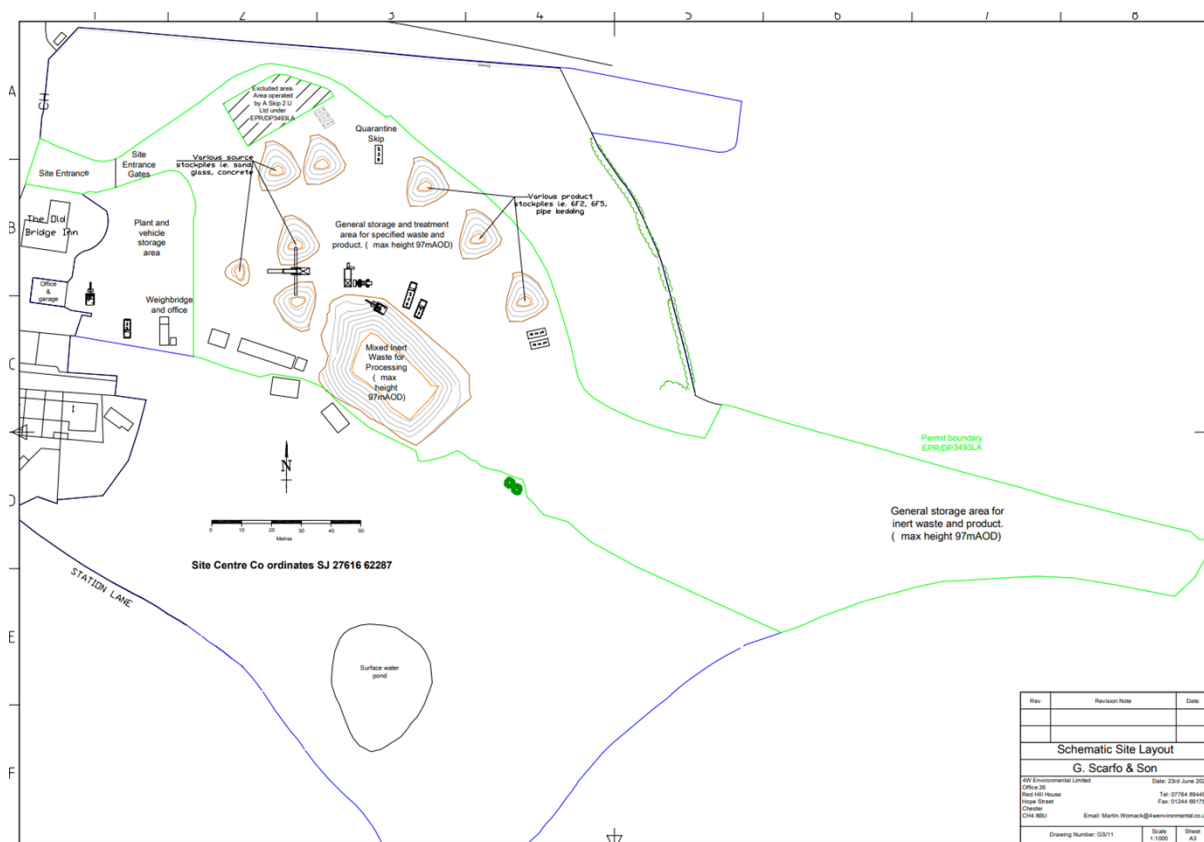
At this time, we do not intend to take any further action.

4. Details of our assessment

On Thursday the 8th April 2025 Natural Resources Wales officers carried out a routine unannounced site inspection. The visit was carried out by Waste Regulation Officer Ian Thomas.

On arrival the officer was met by Martin Scarfo, Technically Competent Manager (TCM) for the permit and owner. I explained the reason for the visit, being partly as a routine inspection and also because some reports had been received about dust, noise and the permit boundary. I discussed these matters with Martin prior to inspecting the site. Martin explained that the treatment and process has not changed, in dry conditions there is a water bowser on site to dampen the area, this is used when required.

The site was operating the same as previous visits, waste brought in from Knauf was being processed, once this is treated it is returned to Knauf. The yard area looks to be well managed with areas allocated to certain customer requirements and processing. The shed allocated to general waste was in use and tidy. Part of the shed is being used for storage of clean soil.

The southern part of the site is used for storage, Martin showed me the area, this was where the concerns were raised regarding the permit boundary. The area has been re organised, there are skips stored and some landscaping has been completed.

The boundary does not look to have been breached, the tree line marks the permit boundary and beyond there is a drop in level where it extends to a natural marsh land also owned by Martin.

I highlighted on the previous visit that there were several locations where gas bottles were found not secured. It is understood that some of these have been found in general waste collections. Martin has assured these gas bottles will be removed or secured.

Action: Please ensure any gas bottles are stored securely.
