Natural resources Wales senior industry and waste regulation officer Carter Shone carried out and announced site inspection at the Bimeda site on the 02/04/25 at 1000.

At the time of the visit the site was operational and the weather was clear and warm.

(IR2A) Permitted activities

After a meeting to discuss any site updates the officer was shown around the site.

No non-compliances were identified.

The waste area was clean and organised.

The bunded chemical stores were viewed and the officer was informed that they are checked monthly by maintenance for any deterioration.

(IR4A) Records

Temperature records for the afterburner that must remain over 800 c were inspected.

No non-compliances where identified.
