4. Details of our assessment

On Monday 19th May 2025 Natural Resources Wales officer Ian Thomas attended site.

This was an unannounced routine inspection for permit DP3493LA.

The last inspection was in September 2024. When I arrived at site, i noted the main gates were closed and appeared to be locked. The site looked to be operational, as there was waste stored in the shed area to be sorted, and some skips were visible on the yard also loaded with varying forms of waste materials.

Also of relevance, were some batteries stored outside of the main door to the shed.



An action was recorded on the last CAR form highlighting this.

Scored C3: Please ensure all waste required to be stored undercover and in a building are moved to comply with the permit condition 2.3.1 (Table 2.3)

Waste batteries should be stored inside or in a weatherproof container which will be protection from the elements.
