4. Details of our assessment

TYN YR ONNEN HEP - ABSTRACTION LICENCE WA/065/0015/0010

An unannounced inspection took place in April 2025 at the Nant y Betws hydropower scheme near Ty'n Yn Onnen Farm, under licence WA/065/0015/0010. The scheme was abstracting at the time of the visit. The intake and infrastructure appeared to be in good condition, and flow was being maintained downstream.

However, there was no fish screen fitted to the discharge outfall, which does not meet the requirements of the licence and must be addressed. A screen with bar spacing no greater than 10 millimetres must be installed and maintained to prevent the entrapment of fish.

It was also noted that nil returns have been submitted for abstracted quantities. This does not comply with the conditions of the licence, which require the quantity of water abstracted to be calculated weekly based on electricity generated. Records must be submitted to Natural Resources Wales within 28 days after 31 March each year. The correct method, using the conversion calculation

provided in the licence, must be followed to ensure accurate reporting.

The site was otherwise tidy and accessible, but the missing fish screen and incorrect data returns must be resolved to bring the scheme into full compliance.

ACTION: Install a fish screen with bar spacing no greater than 10 mm on the discharge outfall, as required by the licence. Once installed, please email photographic evidence to sioned.w.jones@cyfoethnaturiolcymru.gov.uk.
