AFON HARNOG HEP - IMPOUNDMENT LICENCE WA/064/0004/021

An unannounced inspection was conducted on 27/02/2025. Gravel buildup was observed behind the weir at the intake works. This is causing partial obstruction and is not in compliance with condition 4.5 of licence WA/064/0004/021, which requires the intake works to be kept free from obstruction at all times.

The licence holder must remove the gravel and maintain the intake works clear to ensure unobstructed flow. Regular maintenance is advised, and a maintenance schedule would be beneficial. Once the work is complete, please email photographs to sioned.w.jones@cyfoethnaturiolcymru.gov.uk
