4. Details of our assessment

AFON TY CERRIG HEP - ABSTRACTION LICENCE WA/064/0004/017

An unannounced inspection was carried out on the Afon Ty Cerrig HEP scheme on 27/02/2025.

During the visit, gravel was observed behind the intake weir, which may interfere with the flow split and affect compliance with Conditions 9.2(i) and 9.2(ii). These conditions require that 25% of the flow in excess of 20 L/s (winter) or 26 L/s (summer) must be maintained downstream of the abstraction point at all times.

The gravel must be removed and deposited downstream. All work should follow GPP5 guidance and works should stop immediately if any discolouration of the water occurs. This work should be done and maintained regularly to prevent obstruction of flows. A maintenance schedule would be beneficial and is recommended.

ACTION: Remove gravel and deposit it downstream as soon as possible, following
