4. Details of our assessment

CARS form generated following a site visit to Breedon groups Oakley quarry in Blaenau Ffestiniog at 10am on 01/05/25.

The team leader, senior environmental officer and environmental officer from Natural Resources Wales Environment team in Meirionnydd and Dwyfor area met with the works manager and operations manager from Oakley Quarry.

The works manager and operations manager took us around the site. They showed us the current processing area where they were producing the latest products from the quarry. From there we then went to lowest part of the quarry and inspected the 2 pumps that were

in operation.

The works manager then showed us ongoing improvements that are being carried out around the site to improve how the site controls surface water runoff during heavy rainfall events.

We then were shown how to access the permitted discharge point for the quarry. When inspecting the discharge point the water was running clear.

Thank you for your cooperation and showing us water management at the Oakley quarry.
