4. Details of our assessment

CARS form generated following visit to inspect newly issued permit for Llyn Gwynant Campsite.

Environmental Officer for Natural Resources Wales Meirionnydd and Dwyfor team met with Llyn Gwynant campsite owner/director.

The owner/director of the site guided the environmental officer around the foul waste system for the site. The old septic tank that has been converted to a pump station/emergency storage area was inspected first. The waste is then pumped from here to the water treatment system that consist of 4 tanks using aeration to treat the water. The owner

pointed out the the new system can adapt well to the change in use that you can expect from a campsite. The system has sensors and a control panel that can alert staff to any issues with the system.

The system runs on solar power but has the ability to convert to the grid if needed. The owner/director showed me the area where samples are taken to test the effluent. The whole system is checked every Friday to ensure its operating as designed.

From there we then inspected the newly installed sludge tank. The reed bed system to polish the effluent and then the shed that houses the UV treatment and filters.

We then went to inspect the drainage field which was quite a large area where the final effluent is discharge from pipes that run across the field at 10m intervals.

Finally we then inspected the lake and the nearby watercourse. No signs of any non compliance.
