4. Details of our assessment

This compliance report is a follow up from the sample monitoring failure taken on the 31st of March 2024.

Arrived at site on 22nd of April at 10:00am and met onsite staff. Went down to the treatment works where there have been structural improvements made to the area.

Discussed recent sample failings that were taken by NRW monitoring team that were out of compliance. See sample results below taken on 31st of March:

Suspended solids: **73mg/l** (permitted limit: **60mg/l**)

Ammonia: **49.3mg/l** (permitted limit: **20mg/l**)

BOD: **74.9mg/l** (permitted limit: **40mg/l**)

Looking at the trend of failures of this scale for the site, it would seem that this happens at this time of year consistently. It is suspected that this is caused by the lack of activity on site during the months of January and February where the site closed and therefore has no flow through the water treatment works. When the site reopens in March / April, the system cannot cope with the sudden increase of flow due to not receiving feed for a few months prior.

This is something that will have to be investigated by the site and look to resolve the issue to prevent repeat failings going forward.

I will return to site to check in on progress and final effluent quality in June / July this year.
