4. Details of our assessment

Site Report

On Wednesday 26th March 2025, I visited Pen-Y-Banc Farm, Fochriw, Nr. Bargoed, CF81 9NR to undertake a Water Discharge (Sheep Dip) permit inspection on Permit Number GWSE0300. I arrived on site at 13:54. The weather conditions were dry and sunny. My Site inspection commenced at 14:00.

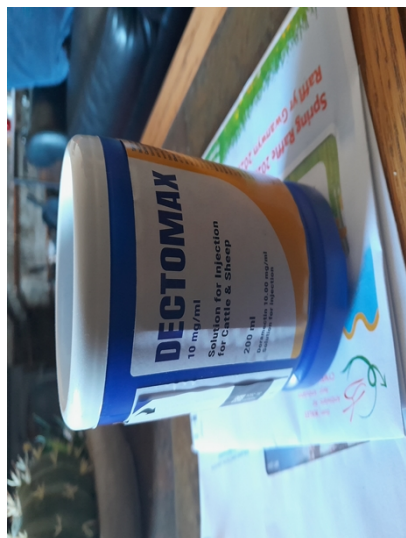
Observations

I was met by Mr William David Chapman. After our introductions I agreed to a walk around

of the site with Mr Chapman present.

I questioned Mr Chapman with regards to the type of sheep dip that was used on site and the storage method and storage location. Mr Chapman advised that no sheep dip was kept on site. Mr Chapman advised an injection method was used. This was stored in a secure area within the farm house. The injections are given in the months of September and October. My Chapman advised no sheep dip activity had been carried out for at least 15 years. Please see Fig 1 below.

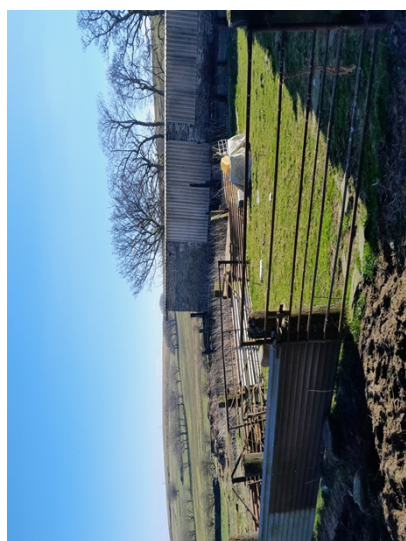
Injection method (Fig 1)



Due to the sheep dip injection method no spreading on land is carried out.

Mr Chapman advised there are approximately 500 sheep on the farm. I asked Mr Chapman to identify the location where the sheep dip process was previously carried out. I can confirm there were no watercourses near this location. Please see Fig 2 below.

Whilst on site I proceeded to check the previous disposal area location. I can confirm this to

be accurate on the map of permit. Please see Fig 3 and 4 below.
