Please note: This inspection concerns site operations only. No data audit was carried out as part of this inspection

I (Environment Officer Gavin Summerhill) arrived at the CSO at Rear of 33 Church Street, Ystrad Mynach, Hengoed CF82 7EF on Wednesday 10th April 2025 at 12:00 to conduct an inspection regarding a licence to operate a water discharge activity (Permit Number

BB3395FK). The weather conditions were dry and sunny. My inspection commenced at 12:15.

The point of discharge at National Grid Reference ST 14439 94217 was accurate as stipulated by the permit. Please see Fig 1 below.
