Waste Regulation Officer Gareth Morris accompanied by Senior Waste Regulation Officer; Craig Coleman and Apprentice Dan Hopkin visited the Associated British Ports, ABP Fletchers Wharf, Compass Road, CF10 4LX on 20/03/2025 to conduct a routine site inspection and to assess compliance with environmental permit: EPR/AB3297FT

The operator holds a Tier Three (3) Bespoke Permit.

Weather on day of inspection, was clear, dry with little wind.

Report Findings

On arrival at the permitted site, it was apparent that there has been no activity on the permitted site recently and that the site is currently non-operational.

Due to the site being no operational there are no permit conditions to assess against and therefore no permit actions or breaches to be recorded.
