I (Environment Officer Gavin Summerhill) arrived at the CSO at Oaks End Close, Penpedairheol, Hengoed CF82 8HZ on Wednesday 2nd April 2025 at 12:50 to conduct an inspection regarding a licence to operate a water discharge activity (Permit Number AN0153701). The weather conditions were dry and sunny. My inspection commenced at

13:00.

The point of discharge National Grid Reference was accurate as stipulated by the permit. Please see Fig 1 below.
