4. Details of our assessment

Sims Group UK Limited Site Visit, Cardiff (AB3993ZF)

Waste Regulation Officer Gareth Morris accompanied by Apprentice; Daniel Hopkin visited Sims Group UK Limited, Sims Tremorfa, Unit 6, Martin Road, Tremorfa Industrial Estate, Cardiff, CF24 5SD to conduct a routine site inspection and to assess compliance with environmental permit: AB3993ZF.

The operator holds a: Tier Three Bespoke Environmental Permit for a hazardous and non-hazardous mixed metal waste treatment and vehicle de-pollution facility.

On arrival at site, we were met by a site operative who kindly showed us around the permitted site.

Weather on day of inspection, was clear, dry with little wind.

Areas assessed as compliant and other comments can be found below.

W1A-General Management

Permit Condition 1.1.1 states: *The operator shall manage and operate the activities:*

- a. *In accordance with a written management system that identifies and minimises risks and pollution, including those arising from operations, maintenance, accidents, incidents, non-conformance, closure, and those drawn to the attention of the operator as a result of complaints.*

Upon asking the operator for a copy of their written management system. The operator provided a copy of their environmental management system (EMS) for inspection.

Permit Condition 1.1.4 states: *The operator shall comply with the requirements of an approved competence scheme.*

The technically competent manager (TCM) attends the site regularly. Richard Morgan is the competent person who holds the WAMITAB certification for the permitted site.

W2C- Operating Techniques

Permit Condition 2.3.1 (a) states: *Waste shall only be accepted if it is of a type and quantity listed in schedule 2 table S2.1, S2.2.*

All waste bays were well displayed, and all waste was correctly segregated. There was no evidence of mixed/contaminated waste.

W2E- Waste Acceptance

Permit Condition 4.2.2 states: *Within one month of the end of each year, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous year.*

The site accepts a number of waste codes. Quarterly returns for the previous quarter have been received on time. The Quarterly returns have been checked against the sites waste codes and are correct.

W2F – Technical Requirements

Permit Condition 2.3.1 Table S1.1 states: *All hazardous and non-hazardous waste must be stored and treated on an impermeable surface with sealed drainage.*

During the site inspection, it was evident that all hazardous and non-hazardous waste was being stored and treated on an impermeable surface with sealed drainage system. The impermeable surface was of a very good quality, with no evidence of damage, rutting or pooling of water.

W3G Fire

Permit Condition 3.5.1 states: *The operator shall manage and operate the activities in accordance with a written fire prevention plan using the current, relevant fire prevention plan guidance.*

The operator was asked to produce a copy of their Fire Prevention and Mitigation Plan (FPMP). The FPMP was produced without delay for inspection and was reviewed while on site.
