Waste Regulation Officer Gareth Morris accompanied by Apprentice Daniel Hopkin visited the Malcolm David Harrison (Diggers Dismantlers) site of 15 Martin Road, Tremorfa Industrial Estate, Rover Way, Cardiff, CF24 5SD. on 24/04/2025 to conduct a routine site inspection and to assess compliance with environmental permit; ZP3295FH

The operator holds a bespoke environmental permit (A13)

The site is an end-of-life vehicle site (ELV)

Weather on day of inspection, was clear, dry with little wind.

Report Findings

On arrival at the permitted site, it was apparent that there has been no activity on the permitted site for some time and that the site is non-operational.

Due to the site being non-operational there are no permit conditions to assess against and therefore no permit actions or breaches to be recorded.
