4. Details of our assessment

This CAR is to record a site visit made by NRW officers BA and LE to IQE Silicon on 27th February 2025.

The site visit was arranged following IQE Silicon informing NRW that they had begun decommissioning their reactors and intended to transfer the permit to another company.

NRW were advised during the visit that the operator is looking to transfer the permit with the full management system. IQEs reactors are to be removed from the site with the new operator to install their own reactors. It is planned that the new operator will take over use of the site equipment including the abatement system, effluent treatment plant, clean room and wafer cleaning facility.

A site tour was undertaken around the reactor rooms, clean room, water treatment plant and outdoor areas.

The reactor rooms were being prepared for removal of reactors. The site continues to run the water treatment plant and wafer cleaning station. 8 x 200L drums of wafer cleaning liquids were seen to be housed in bunded containment units.

Whilst outdoors, the abatement system and effluent treatment plant were viewed with no changes to these facilities being observed during the visit.
