4. Details of our assessment

Please note: This inspection concerns site operations only. No data audit was carried out as part of this inspection

I (Environment Officer Gavin Dodd) arrived at the CSO at Tir-y-Berth, Hengoed on Monday March 17th 2025 at 10:00 to conduct an inspection regarding a licence to operate a water discharge activity (Permit Number AN0092501). The weather was sunny and dry.

The CSO was discharging at the time of the visit but there was no indication of ragging around the outfall or in the watercourse. Grid reference points were accurate to those

provided on the permit for both the point of discharge and the monitoring point. The discharge point was accessed from a nearby dirt footpath but this was largely overgrown. It was not possible to inspect the screening for the CSO as the chamber was padlocked.
