4. Details of our assessment

This report details the site visit made on the 15 May 2025 to D&E Scrap Metal LTD, permit reference number EPR-BB3290CW. NRW Officers Carla CURTIS and Mark O'GORMAN attended site at Adelaide St, Crindau, Newport, NP20 5NF for a routine site inspection following a fire at site on 25 April 2025, the weather was warm and sunny.

GENERAL OBSERVATIONS - Officers were accompanied around the site and the following observations were made. The general housekeeping of the site was of a good standard, and the infrastructure on site appeared to be in good order with no cause for concern. There were no offensive odours or noise witnessed by NRW Officers whilst on site. Some of the fencing was damaged at the back of the site (see photo 1 right hand side), David EAGLE mentioned that he is in the process of replacing the fencing.

FIRE INCIDENT – 25/04/25 11:30pm, the Fire and Rescue Service (FRS) reported an incident to NRW (WIRS **2504126**) of a fire taking place at D&E Scrap Metal Ltd.

It is believed the cause of the fire was most likely a Lithium battery. NRW Officers advised that the site review their FPMP to help prevent and or mitigate any future potential incidents.

Action - Please send a copy of the new updated FPMP.

WAMITAB - The Technically Competent Manager for the site is Tania EAGLE who holds an up-to-date qualification at the time of the inspection.

Action – Please send a copy of WAMITAB certificate.

WASTE RETURN SUBMISSIONS - The maximum waste quantity that can be accepted by the site is 5,000 tonnes per year. Information contained within the waste returns appears to be up to date and within permit limits. Please continue to submit quarterly waste returns within one month of the end of each quarter, in line with your permit
