4. Details of our assessment

Please note: This inspection concerns site operations only. No data audit was carried out as part of this inspection

I (Environment Officer Gavin Dodd) arrived at the CSO at Glan-yr-Afon Nursing Home, Ebbw Vale on Monday March 17th 2025 at 10:30 to conduct an inspection regarding a licence to operate a water discharge activity (Permit Number AN0331301). On the occasion of the visit, the weather was sunny and dry.

The CSO was not discharging at the time of the visit but showed signs of having discharged recently. Grid reference points were accurate to those provided on the permit for both the point of discharge and the monitoring point. The discharge point was accessed from the rear garden of the nursing home. There was no sewage ragging on the outfall plinth, though there was some evidence of ragging on trees nearby and around the discharge pipe. It was not possible to inspect the screening for the CSO as the chamber was padlocked.
