4. Details of our assessment

This report details the site visit made on the 12 March 2025 to Raymond Fleming permit reference number EPR/CB3699ZR.

Natural Resources Wales (NRW) Officer Carla CURTIS and Greg GARDNER attended the Raymond Fleming site at The Hill Farm, Monmouthshire, at 10:30 where we met with the Landlord.

GENERAL OBSERVATIONS

Raymond Fleming is seeking a permit surrender for the whole site, under permit EPR-CB3699ZR. The purpose of the visit was to complete a final site inspection to facilitate the determination of the surrender application. At the time of the inspection, all operations on site had ceased, all waste(s), and machinery had been removed. Based on the visual inspection of this site, NRW Officers feel that the risk to the environment is sufficiently low and would recommend that no intrusive site inspection is required.

To confirm, based upon the type of permit held by Raymond Fleming – (Permit Number - EPR-CB3699ZR) and operations previously undertaken on site, it is my recommendation that this permit would be eligible for a low-risk surrender.
