4. Details of our assessment

Compliance inspection undertaken of Cardiff Central SPS AN0306101 by Environment

Officers Harry Warburton, Hannah Jenkins and Alex Grainger accompanied by DCWW.

Cardiff Central SPS is located on site at Cardiff STW and is next to Ocean Park SPS. Central SPS passes forward the catchment flows for the Cardiff central catchment into the works at a rate of 1263L/S and with a permitted storage capacity of 6647m³.

It was mentioned by DCWW operators that the site had recently undergone refurbishment, including reconditioning the screens. There are 4 storm screens on this site, these could not be observed due to requiring a crane to lift the large concrete covers, this is done during yearly maintenance which was said to be after the summer. NRW raised concerns that the maintenance should be completed prior to the start of the bathing season since these assets can have an impact on designated bathing waters. NRW will have to reattend during the maintenance to observe the screens.

The discharge location is at the foreshore just out of the site boundary, the outfall is a shared outfall with Ocean Park SPS and was submerged by the tide at the time of attendance.

Action:

- Review the maintenance schedule for this asset so that it is done prior to future bathing seasons.
