4. Details of our assessment

Routine site inspection of Trellech Wastewater Treatment Works carried out by Environment Officer Peter Jones. On the day of the inspection, It was bright sunshine with no rain. There had been no significant rain within the last 48 hours.

The current permit was issued on the 25 June 2024. It's a numeric permit with a Dry Weather

Flow limit set at 20.8 m³ per day. Currently, the emission limits for the permit, set out in Table S3.1a, are in place until the 1 July 2025. On the 2 July 2025, these are replaced by the emission limits set out in Table S3.1c.

Effluent enters the works and flows to a primary settlement tank, and then into a filter bed before final treatment in a humus tank. The site is well maintained and looks to be operating effectively.

A visual check of the final effluent was made, the effluent looked clear and there was no evidence of fungus. The site diary was up to date.

The location of the discharge point set out in table S3.2, lists the discharge point as SO49694 05093. This is incorrect, DCWW staff on site advised the discharge point was approximately at grid reference SO4993405510. (What three words location cakewalk.profile.altitude)

This is a breach of permit condition 2.2.1. The condition sets out the location at which the final effluent discharge may occur. See attached map of discharge point.

Actions

A permit variation should now be submitted to ensure the permit lists the correct location of the final effluent discharge point.
